My mom told me soon after the accident that if I wanted to do something all I had to do was figure out a way to make it happen. Throughout my life there have been few if any challenges that I have not been able to succeed in accomplishing. Trials make us stronger. They raise us up to a higher plain. If we are never pushed and challenged we can never obtain our full potential. For me it was losing my legs. Property From a Risk and Claims Perspective Tim Bauer, SDAO & Troy DeYoung, PACE

In this session PACE Risk Management Consultant Troy DeYoung will take you through looking at property from a risk management prospective. We will walk through what the risk management process looks like when you are trying to mitigate losses to your properties. This will include looking at risk controls you can put in place to mitigate losses and reduce the severity if one occurs. Additionally, Executive General Property Adjuster Tim Bauer will go through frequent types of perils, what causes these losses, mitigating activities once a loss occurs, common coverage explanations, and pre-loss planning.

Along with applying property claim coverage evaluations and settlements for water, fire, wind, smoke, & theft losses, Tim has adjusted multi-location Oregon SDAO events including the 2021 Portland Freeze claims, 2020 Oregon Wildfires, 2019 Southern Oregon Wind Storm, and 2017 Central Oregon Ice Storm.

After studying Business Management and Industrial Engineering at Oregon State University (B.S. 1992), Tim started in the property insurance industry with an Insurance Restoration Contractor then moved to property claims adjusting in 1997. Tim's 25+ year claims career has specialized in major-loss adjusting of commercial, public entity, and residential losses. Tim has adjusted these large losses throughout the US including schools, food manufacturing, commercial laundry, restaurants, shopping centers, assisted living, apartments, etc. Tim also handled claims from hurricane Katrina, Ike, and multiple Midwest tornado and hail events.

TROY DEYOUNG; ARM

Risk Management Consultant

Special Districts Assoc. of Oregon

Troy has been working with public entities in Oregon since 2005 as a Risk Management Consultant for Special Districts Association of Oregon (SDAO) which includes two insurance pools, the Special Districts Insurance Services Trust (SDIS) and Property and Casualty Coverage for Education (PACE). These pools have approximately 1300 members. Troy regularly visits SDAO and PACE members to assist with risks related to general liability, property and workers' compensation.

Troy's educational background is in the fire service industry and prior to coming to SDAO he worked in the semiconductor industry for Intel Corporation as a Life Safety Engineering Technician. Troy received the 2012 Silver Sparky award from the Office of the Oregon State Fire Marshal, which is the highest honor a civilian can receive in the fire service, for his work on the PACE/SDAO Report School Fires program. Troy also completed the associate in risk management program receiving the ARM designation in 2020.



IPM ROUNDTABLE TIM STOCK - Lead for the Oregon State University IPM Program

The Program works with schools statewide to improve pest management while reducing the risks associated with both pests and pesticides. He conducts hands-on IPM training and assessments at schools throughout the state, provides one-on-one consultations, and produces a variety of supportive resource materials. He serves on the National School IPM Steering Committee.

He has also worked extensively in Africa, Asia and Latin America, on community-based health and human settlements improvement as well as agricultural development. He received his MS degree in Agricultural Extension at the University of Reading in England.

Richard Donovan joined the OSBA legislative team in September 2016.
